## **RESOLUTION NO. 2020-13**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF CLEWISTON, FLORIDA, ADOPTING AMENDMENTS TO THE BUDGET FOR FISCAL YEAR 2019 - 2020; AND, PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS,** the City of Clewiston, Florida, must adopt amendments to the budget for the fiscal year 2019-2020, and

**WHEREAS,** it is necessary that revenues and appropriations be made for said fiscal year as shown by the following budget amendments summarized here and attached and made a part hereof:
